In 2008, Australian imports of consumer-ready food products from the U.S. reached a record US\$623 million, representing almost 11% of Australia's total imports of this category of products. The U.S. is Australia's second largest supplier of consumer-ready food imports. The U.S. — Australia Free Trade Agreement resulted in tariff rates for all U.S. food products exported to Australia dropping to zero.

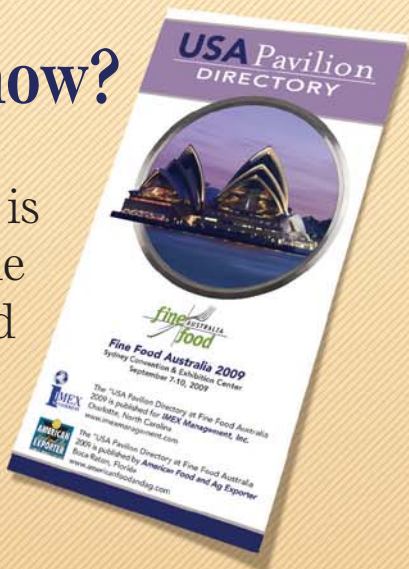

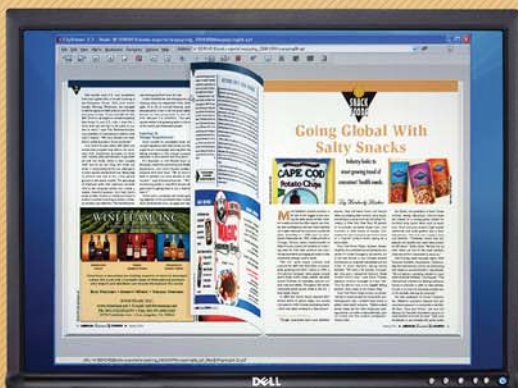
